2. Teleconference — Call in to the meeting by dialing (301) 715 8592; Webinar ID: 898 7048 3053. Press *6 to mute or unmute your line. If you would like to make a comment during the meeting, press *9 to enable the "raise hand" feature.

- Once the Clerk calls on you, unmute and identify yourself when you speak so others know who is talking and so we can correctly identify you in the meeting minutes.

3. Email — You also may email comments no later than 4:00 PM on Tuesday, September 15, 2020. Submit public comments to CityClerkOffice@brentwoodmo.org.

- Public comments, provided they comply with the City's guidelines, will be read during the meeting, made a part of the official record of the meeting, and made accessible to the public online following the meeting.
