 - If you are not speaking, please mute yourself via your phone mute or the Zoom application muting option.
2. Teleconference — Call in to the meeting by dialing 301-715-8592 /// Webinar ID: [99537306246](https://zoom.us/s/99537306246). Press *6 to mute or unmute your line. If you would like to make a comment during the meeting, press *9 to enable the "raise hand" feature.
 - Once the meeting host calls on you, unmute and identify yourself when you speak so others know who is talking and so we can correctly identify you in the meeting minutes.
3. Email — You also may email comments no later than 4:00 PM on Thursday, October 15, 2020. Submit public comments to smuskopf@brentwoodmo.org.
 - Public comments, provided they comply with the City's guidelines, will be read during the meeting and made a part of the official record of the meeting.
