Requirements & Guidelines:

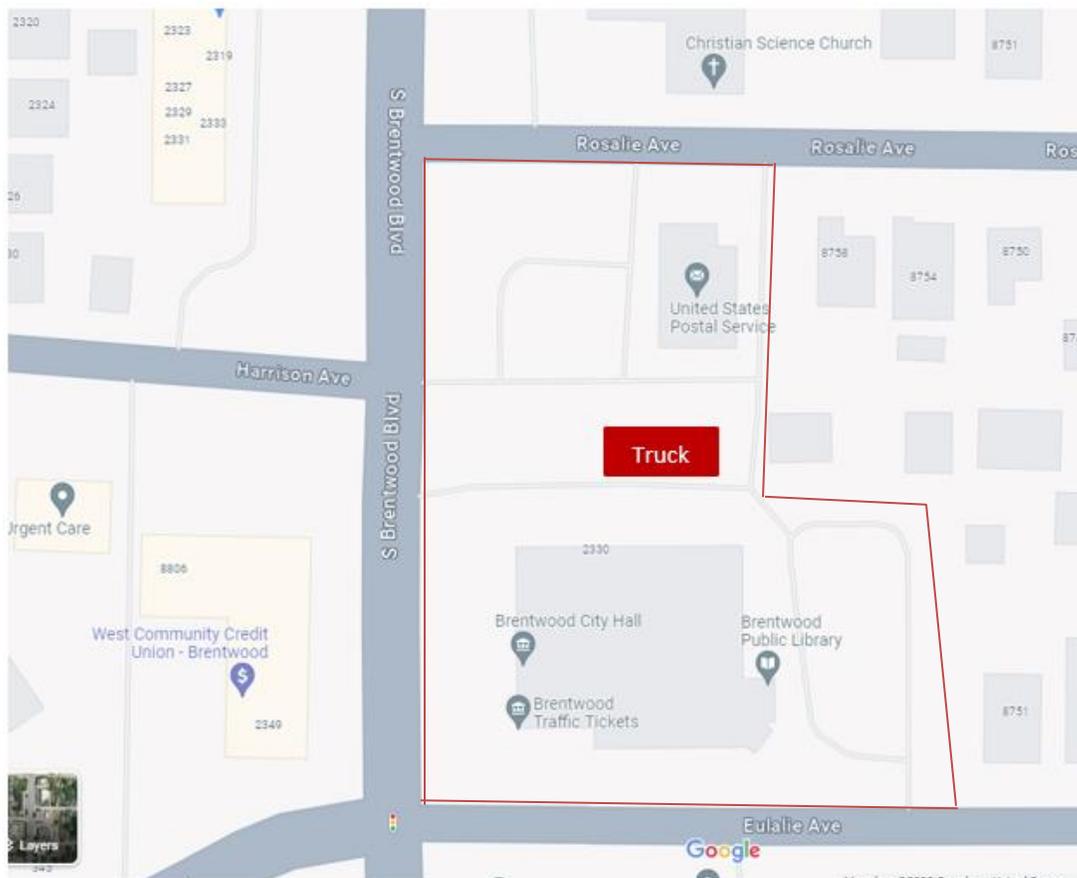
1. Special Events with Mobile Food Vendors will require individual vendors to apply for a Mobile Food Vendor permit.
2. Events with Tents and Awnings need to be shown on the site plan.
3. Provide placement of any signage on the site plan.
4. No mobile food vendor shall operate, conduct business, or have merchandise,
5. Free standing signs shall not be permitted. Signs shall be confined to those already attached, affixed, or applied to the truck, trailer, or cart.
6. *Events selling liquor must get approval by the Board of Alderman prior to approval of the Special Use Permit.
7. **The certificate of insurance shall name the City of Brentwood as additional insured and indemnify and hold harmless the City of Brentwood.*

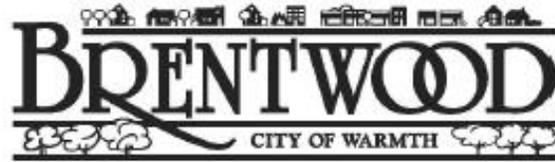
