COURT ORDER

ESTABLISHMENT OF VIOLATIONS BUREAU  
AND  
SCHEDULE OF OFFENSES AND FINES

EFFECTIVE JANUARY 1, 2020

I am the judge of the Brentwood Municipal Division of the circuit court for the 21<sup>st</sup> Judicial Circuit of Missouri. I have original jurisdiction over animal control violations, housing violations, and traffic violations in this municipal division. By this court order, I am establishing a violations bureau (subject to the supervision of the circuit court) that includes animal control violations, housing violations, and traffic violations.

I hereby designate Christine Schwartz, Court Administrator, and her designated assistants as violation bureau clerks, and said clerks shall perform the duties required by the Court including accepting appearance, waiver of trial, plea of guilty, and payment of fines and court costs as set forth below. It is further ordered as required by Rule 37.49, that this schedule be prominently posted at the place where fines are to be paid.

Pursuant to 479.050, RSMo, Supreme Court Rule 37.495, I hereby adopt the Uniform Fine Schedule and order that following designated offenses shall be payable to the Brentwood Municipal Division Court Violations Bureau. In such cases, no court appearance is necessary.

In accordance with Missouri statutes and ordinances adopted by the City, total court costs shall be \$29.50. This includes:

Court costs shall be paid in addition to the fine except where prohibited by Missouri state statute. This schedule shall supersede all previous schedules of offenses and fines and shall be applicable only to those violations disposed of prior to the scheduled court appearance noted on the summons by payment either in person at the violations bureau, by mail, or online. Said payment constitutes a guilty plea and waiver of trial.
